Plaintiff MICHELLE LORI BLIVEN, by COMES NOW, through her attorney GARY L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and Defendant, KENNETH R BLIVEN, who hereby agree and stipulate as follows:

- That in an Order filed May 25, 1995, in the Ninth Judicial District court of the State of Nevada, County of Douglas, Defendant was ordered to pay the sum of \$360.00 per month as ongoing support of his minor children, CHRISTOPHER L. BLIVEN Born: 04/27/76; BRAD S. BLIVEN Born: 12/06/80; ADRIENNE R. BLIVEN Born: 11/16/82; and DANIEL G.V. BLIVEN Born: 04/24/84.
- That in the above-mentioned order, judgment was in favor and Plaintiff and against Defendant in the amount of 4,845.20 for child support arrears.
- Defendant now owes \$4,935.20 in child 3. That support arrearages through and including September 30,

Defendant has paid \$190.00 toward his October child support obligation, and will pay the remaining \$150.00 through an existing wage withholding.

- 4. That the Defendant shall pay \$360.00 per month as ongoing support, plus \$30.00 per month toward satisfaction of child support arrears for a total of \$390.00 per month. That Defendant's first \$390.00 monthly payment shall be due on November 1, 1994, and continue due on the first day of each and every month thereafter until Defendant's arrearages are paid in full or until further order of this court.
- 5. That Defendant's child support payments shall be made by wage withholding.
- that, in the Defendant understands becomes unemployed or underemployed, all child support payments made by him to Plaintiff must be in the form of cashier's check, certified check, or money order, or in cash. The Defendant further understands that if the payment is in the form of cash it must be delivered to the Douglas County Clerk at her office in Minden, Nevada. If the payment is in the form of a cashier's check, certified check, or money order, Defendant understands that it must be made payable to the DOUGLAS COUNTY CLERK, with the notation Case No. 940094 (KENNETH R BLIVEN), and be either mailed to the Douglas County Clerk at Post Office Box 218, Minden, Nevada 89423, or delivered to said County Clerk at her office in Minden, Nevada.

Defendant agrees that he shall notify the Douglas 8. County District Attorney's Office in writing within 10 days of any change in Defendant's mailing address, home address, or employment.

Defendant understands that this support order may 9. be reviewed every three years at the request of either party in accordance with NRS 125B.145.

10. Defendant understands that failure to pay his support as required by the order entered in accordance with this stipulation will subject him to possible contempt of court with a penalty of 25 days in jail.

11. That in exchange for Defendant's higher arrearage payment the District Attorney's Office agrees to lift the lien filed June 2, 1994, to enable the Defendant to purchase a home. That the lien will be lifted for a period not to exceed 30 days. However, if Defendant cannot purchase his home within 30 days, he will notify the District Attorney's Office and will be granted an additional 30 day extension.




