

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 31 day of January, 19 95,
between, NEVADA JOHNSON INC., a Nevada Corporation
herein called TRUSTOR

and MARQUIS ESCROW INC., a Nevada Close Corporation, herein called TRUSTEE, and

WITNESSETH: That Trustor irrevocable grants, transfers and assigns to Trustee in trust, with power of sale, that property in Douglas County, State of Nevada, being Assessment Parcel No. 29-480-46, more specifically described as follows:

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

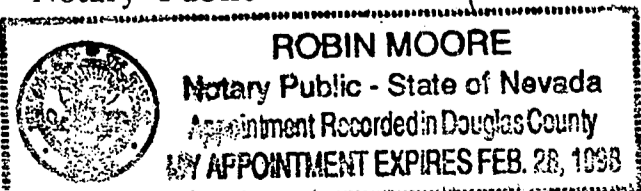
