WHEREAS, Struthers and Zents intend to marry each other; and WHEREAS, both parties desire to enter into an agreement whereby each will disclose to the other his or her separate properties and acknowledge that each desire to retain independent control of their separate properties; and

WHEREAS, the parties are desirous of reducing such agreement to writing;

NOW, THEREFORE, it is agreed by and between the parties hereto that, in consideration of the mutual understandings and undertakings which are recited herein, and other good and valuable consideration, it is hereby agreed as follows:

- 1. Struthers is possessed of the separate properties and separate obligations listed on Exhibit "A" attached hereto and incorporated herein by reference.
- 2. Zents is possessed of the separate properties and separate obligations listed on Exhibit "B" attached hereto and incorporated herein by reference.
- 3. The parties are in possession of certain jointly held properties listed on Exhibit "C" attached hereto and incorporated herein by reference.
- 4. Each of the parties hereto shall retain title, management and control of the properties now owned by them, whether real, personal or mixed, entirely free and unmolested by the other party and may encumber, sell, dispose, give or provide by Will for the disposition of any or all of said assets so separately owned or possessed; that at the death of either, no claim by community

property shall be made by either of the parties hereto against said separate property or against the estate of the other, except for properties acquired from and after the date of marriage which are held in joint tenancy or as community property; any property acquired after the date of marriage in the name of one spouce alone shall be deemed to be said spouse's separate property. This Agreement, however, shall not be construed to prevent either party from taking anything which is specifically left to such party under or by virtue of any Will or testamentary disposition to the other, or by intestate succession.

- The separate property of the parties shall, in fact, remain separate property even though community funds may be used to improve the same or the proceeds therefrom are co-mingled with Should community funds or the separate funds of community funds. one spouse be used to improve the separate property of either party the property shall, in fact, remain separate and there shall be an irrebutable presumption that the moneys so used are, in fact a non-refundable gift. There shall be no presumption in favor of community property, but rather a presumption shall exist that the property is, in fact, the separate property of the party in whose name said property appears. Only property which is acquired after the date of marriage or property listed on Exhibit "C" which is held as "community property" or as "joint tenancy property" shall be presumed to be community property.
- Should the parties desire to dissolve their marriage at a future date, and should an action for divorce be commenced, each party agrees that he or she shall make no claim against the estate of the other which is contrary to this Agreement, but rather both parties covenant and agree to execute a property settlement agreement and any and all other documents which are reasonably necessary to carry out the full intent and purpose as existing herein.
