

SUBSTITUTION OF TRUSTEE

WHEREAS, on March 7, 1993, Lideo A. Tibayan and Mary Ann W. 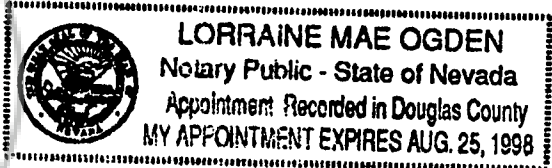
