

SUBSTITUTION OF TRUSTEE

WHEREAS, on February 19, 1991, Deborah E. 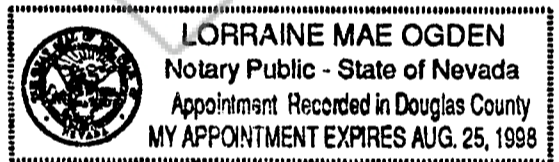
