STIPULATION

COMES NOW, Plaintiff RENNIE C PAXTON, by and through her attorney GARY L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and Defendant, LARRY RAY PAXTON, who hereby agree and stipulate as follows:

1. That in an Order filed February 7, 1995, in the Ninth Judicial District Court of the State of Nevada, Defendant was ordered to pay the sum of \$600.00 per month as ongoing support of his minor children, RAELEY C PAXTON Born: 09/23/81; and DUSTIN R PAXTON Born: 01/24/79.

2. That Defendant has accrued child support arrearages in the amount of \$1,301.00 through and including April 30, 1995, in addition to \$600.00 owed by Defendant as ongoing child support for May, 1995, for a total arrearage of \$1,901.00.

2 3. That the Defendant shall pay to the Douglas County
3 Clerk the sum of \$500.00 on Friday, May 12, 1995, and \$500.00 on
4 Friday, May 19, 1995.

5 4. That following Defendant's \$500.00 payment on
6 Friday, May 19, 1995, Defendant shall pay \$600.00 per month as
7 ongoing child support, together with \$250.00 per month toward
8 satisfaction of child support arrearages, for a total payment of
9 \$850.00 per month. That Defendant's first \$850.00 monthly
10 payment shall be due on June 1, 1995, and continue due on the
11 first day of each and every month thereafter until his child
12 support arrearages have been paid in full.

13 5. That when Defendant has paid his child support
14 arrearages in full, he shall continue to pay \$600.00 per month
15 as ongoing child support.

16 6. Defendant and Plaintiff hereby waive the immediate
17 wage withholding requirement for the reason that the Defendant
18 is temporarily employed. Defendant understands that a wage
19 withholding will be initiated by the District Attorney's Office
20 without further notice if Defendant becomes 30 days delinquent
21 in his child support obligation.

22 7. Defendant understands that, in the event he
23 becomes unemployed or underemployed, all child support payments
24 to be made by him to Plaintiff must be in the form of a
25 cashier's check, certified check, or money order, or in cash.
26 The Defendant further understands that if the payment is in the
27 form of cash it must be delivered to the Douglas County Clerk at
28 her office in Minden, Nevada. If the payment is in the form of

1 a cashier's check, certified check, or money order, Defendant
2 understands that it must be made payable to the DOUGLAS COUNTY
3 CLERK, with the notation Case No. 950100 (LARRY RAY PAXTON),
4 and be either mailed to the Douglas County Clerk at Post Office
5 Box 218, Minden, Nevada 89423, or delivered to said County Clerk
6 at her office in Minden, Nevada.



8 8. That the Defendant shall provide medical insurance
9 coverage for his minor children if available through employment
10 or other group policy.


11 9. Defendant agrees that he shall notify the Douglas
12 County District Attorney's Office in writing within 10 days of
13 any change in Defendant's mailing address, home address, or
14 employment.

15 10. Defendant understands that this support order may
16 be reviewed every three years at the request of either party in
17 accordance with NRS 125B.145.

18 11. Defendant understands that failure to pay his
19 support as required by the order entered in accordance with this
20 stipulation will subject him to possible contempt of court with
21 a penalty of 25 days in jail.
