

SUBSTITUTION OF TRUSTEE

WHEREAS, on June 6, 1992, Rudy R. 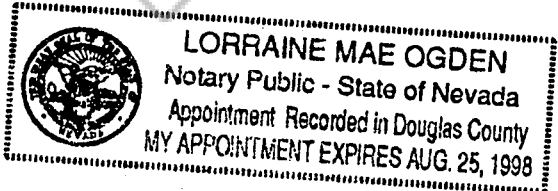

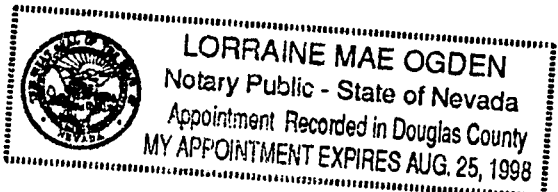
