

SUBSTITUTION OF TRUSTEE

WHEREAS, on March 30, 1991, Miguel M. Gonzalez and Sharon G. 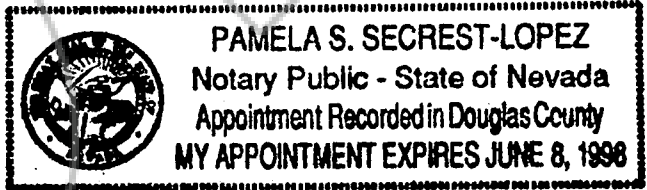

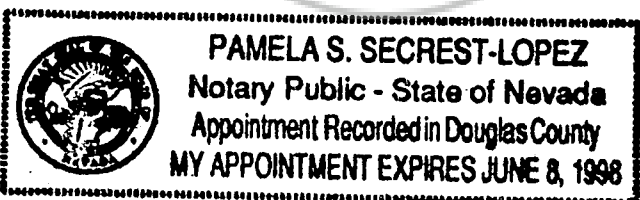
