I further declare that I have seven (7) grandchildren, to wit: Michael Howard Horton, and Matthew Jay Horton, and Lance Alan Horton, and Scott David Horton, and Jean Margaret Horton, and Paul Christopher Horton, and Kathleen Leslie Horton.

Upon my death, my sons, Barry Eugene Horton and Hughie Alan Horton, shall become the "successor co-trustees". Should either one of my sons predecease me, then the survivor shall be the "successor trustee". The "successor trustee(s)" shall have no bond required of them and they agree not to request compensation in regards to their duties.

My estate consists of my residence, which is separate property, title being held by me alone. It further consists of my personal furniture, antiques, keepsakes, and accounts.

Upon my death, the "successor co-trustees", or either of them, as the case may be, shall take charge of the Trust, with all powers and control, and disburse my assets as follows:

9 my entire estate.

10 5. I have intentionally omitted my grandchildren, Paul  
11 Christopher Horton and Kathleen Leslie Horton, from  
12 sharing in my estate.

13 6. Should my Husband, Sim Henry Gilzow, survive me, then he  
14 shall be allowed a reasonable period of time in which to  
15 remove his personal belongings, in order to move to his  
16 property in the State of Texas.

17 The "successor trustee(s)" shall have the same discretionary  
18 powers as the "Settlor" and "Grantor" had.

19 I, MARY ELIZABETH GILZOW, hereby specifically provide for  
20 the payment of costs for my last illness and funeral expense.  
21 These are to be paid first, prior to any distributions of any  
22 sort.

23 Should any part of this "Living Trust" be found invalid, it  
24 shall not be construed as invalidating the entire document. Any  
25 assets so affected shall pass through my "Will", created only for  
26 this possibility.

27 The Trustor, Settlor (Grantor), hereby reserves the right to  
28 use all of the assets of this "Trust" in a manner whereby no

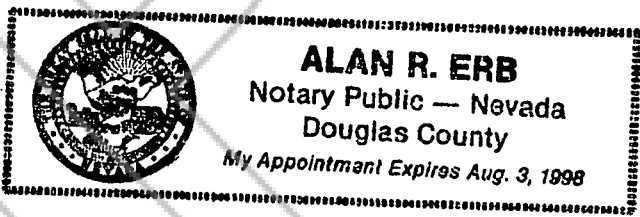
