
### Assignment of Deed of Trust

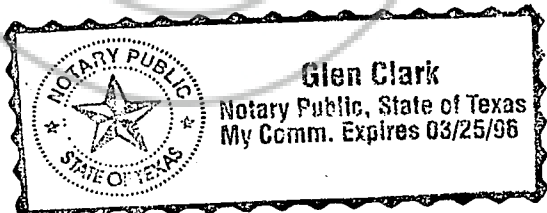


