

SUBSTITUTION OF TRUSTEE

WHEREAS, on November 24, 1989, Lanette M. 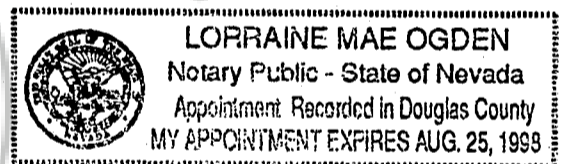
