SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 29 day of September, 1995,

between, WILLIAM B. LOFTIS AND JOYCE ANNE LOFTIS husband and wife, as Tenants in Common herein called TRUSTOR

and MARQUIS ESCROW INC., a Nevada Close Corporation, herein called TRUSTEE, and

DONALD JAMES TYLER, Trustee U/T/A dated December 8, 1992 DONALD JAMES TYLER 1992 FAMILY TRUST AGREEMENT, as to an undivided 72.5625% interest AND MICHAEL BRAY AND JUDY BRAY, husband and wife as Joint Tenants with right of survivorship as to an undivided 27.4375%, herein called BENEFICIARY.

WITNESSETH: That Trustor irrevocable grants, transfers and assigns to Trustee in trust, with power of sale, that property in Douglas County, State of Nevada, being Assessment Parcel No. 21-160-40, more specifically described as follows:

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada, in the book and at the page thereof, or under the document file number, noted below opposite the name of such county, namely:

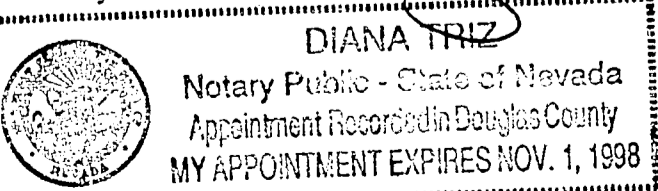
