The defendant shall notify the Douglas County District Attorney's Office of any change in home address, mailing address, telephone number, employment, or medical insurance availability within ten days of any change.

## IT IS FURTHER ORDERED THAT:

Defendant's first monthly child support obligation shall be due on the first day of October, 1995, and shall continue due on the first day of each and every month thereafter until further order of this court.

That when defendant's minor child emancipates, defendant shall continue to pay \$200.00 per month toward satisfaction of then existing child support arrears in accordance with NRS 125B.100.

That defendant's ordered monthly payment on child support arrearages does not preclude other methods of collection for child support arrears.

This support order shall be reviewed every three years in accordance with NRS 125B.145.
