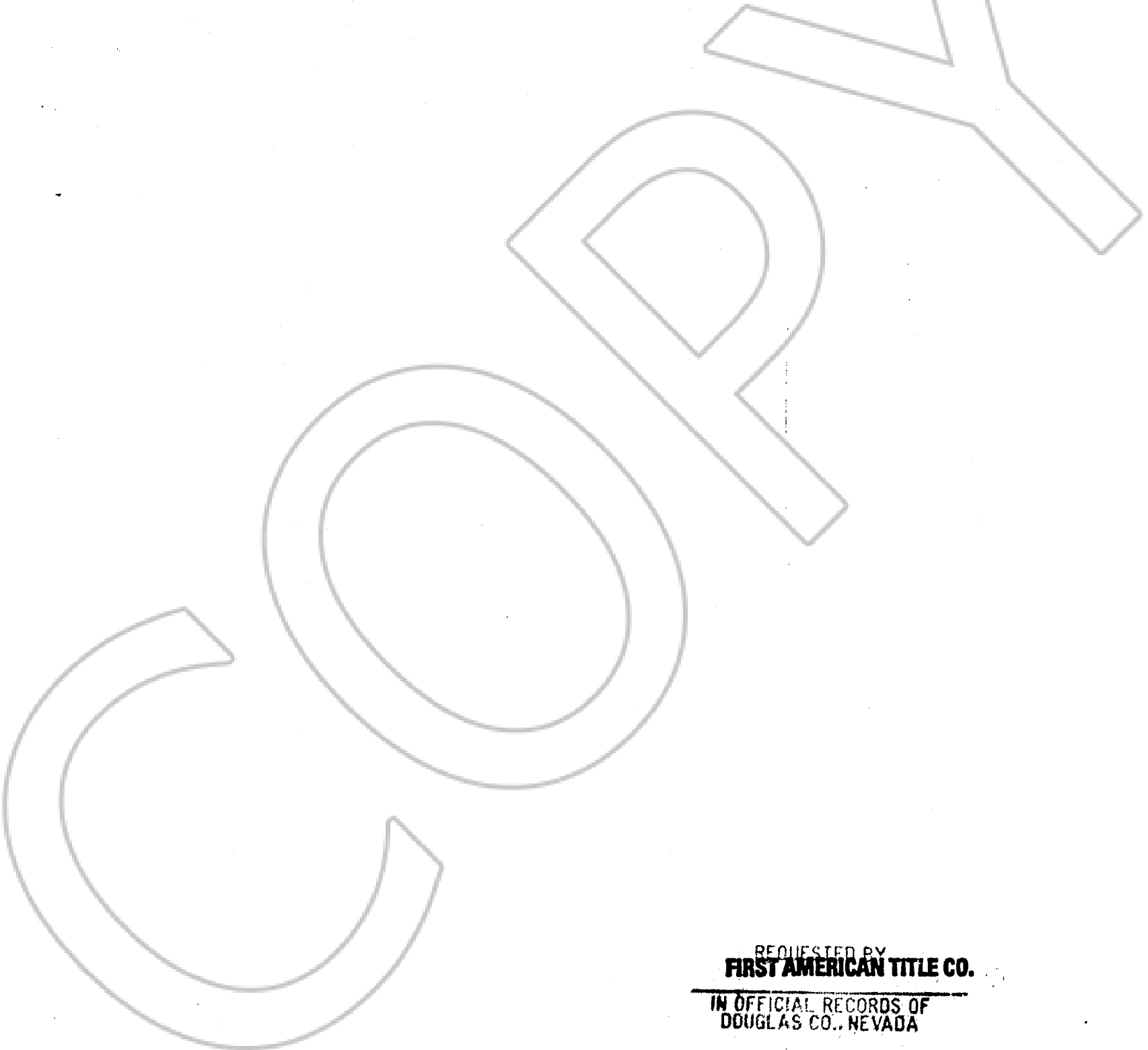


DESCRIPTION
