Order: 2 The Court finds that there are no genuine issues of 3 material fact to be decided by the Court. Plaintiff is seeking 4 recovery of money paid toward goods that were not delivered by 5 the Defendant. Summary judgment is appropriate in light of the 6 fact that the Plaintiff is not seeking the benefit of his bargain, or any losses sustained because of non-delivery by the 8 Defendant, but simply seeks to cancel the contract and recover 9 so much of the price as has been paid. The Court need not 10 consider Defendant's claimed defenses of impracticability or 11 impossibility, because the Plaintiff is not requesting 12 enforcement of the contract. 13 14 Mr. Brengman was to deliver to Mr. Froese a partially 15 constructed automobile for the sum of \$31,200.00. 16

Mr. Froese and Mr. Brengman entered into a contract whereby Mr. Froese paid Mr. Brengman the total sum of \$36,595.00. Mr. Brengman has not delivered the assembled kit car or "rolling chassis" that Mr. Brengman contracted to deliver to Mr. Froese, nor has Mr. Brengman returned any of the money paid by Mr. Froese. Brengman is not financially able to perform his obligations under the contract and deliver the goods. Pursuant to NRS 104.2711, Mr. Froese is entitled to recover the money he paid to Mr. Brengman:

Where a seller fails to make delivery or repudiates...the buyer may cancel and whether or not he has done so may in addition to recovering so much of the price as has been paid:

(b) Recover damages for nondelivery as provided in this article. (NRS 104.2713).

The Court will not award attorney's fees in this matter because NRS 104 et seq. does not specifically address attorney's fees and the Court can not find that Mr. Brengman's defense of this action was brought without reasonable ground or to harass Mr. Froese. However, pursuant to NRS 18.020, Mr. Froese is entitled to reimbursement for his costs of suit.

THEREFORE IT IS HEREBY ORDERED that Plaintiff's Motion for Summary Judgment is GRANTED, and JUDGMENT is entered against the Defendant and in favor of the Plaintiff in the sum of THIRTY SIX THOUSAND FIVE HUNDRED AND NINETY-FIVE DOLLARS AND NO CENTS. (\$36,595.00).

IT IS FURTHER ORDERED that Plaintiff's request for attorney's fees is DENIED.

IT IS FURTHER ORDERED that Plaintiff is awarded costs in an amount to be approved by the Court.
