15 5. That the Court does hereby retain jurisdiction of the above-entitled estate until the same
16 shall be distributed and closed, and that upon said Executor filing a supplementary accounting
17 showing payment of all sums of money due from him, and that he has delivered up all the remaining
18 property of the estate to the beneficiary entitled thereto, that a decree of discharge shall be entered
19 and filed discharging said Executor from all liability thereafter to be incurred.
