IT IS FURTHER ORDERED that JOHN EUGENE DUNLAP, MARSHALL BARTELS, RUTH ELLEN ERWIN and SCOTT BARTELS are appointed successor co-trustees of the BARTELS FAMILY TRUST dated March 11, 1961, in the name, place and stead of RAYMOND HERMAN BARTELS, now deceased, ARTHUR JOHN BARTELS, who is now incapacitated, and ERNESTINE MARIE DUNLAP, who has requested that this Court remove her as the sole acting co-trustee of the

1 BARTELS FAMILY TRUST.
