2 **MORGAN to quiet title to the real property time share interval set forth in Paragraphs 10, 11,**
3 **12, 13 and 14 of the Complaint. In addition, the Plaintiff sought to foreclose liens as to the**

14 **pleading has been filed by any of the Defendants.**

18 **IT IS HEREBY ORDERED that a Default, pursuant to NRCP Rule 55 be entered as to**
19 **all the above-named Defendants.**

20 **IT IS FURTHER ORDERED AND DECREED as follows:**

22 **1. That the liens of the Plaintiff as to all the Defendants above-named and as set**
23 **forth on Exhibit "A" attached hereto, are hereby foreclosed and that TAHOE VILLAGE**

25 **clear of all claims, rights or interest of said Defendants.**

1 2. That the Defendants JESSE E. TAYLOR, JR., THE CHARLES COMPANY, a
2 Nevada corporation, BLANCHE JARRETT and JONI A. JARRETT, MILDRED WEINHEIMER
3 and LARRY J. MORGAN have no right, title or deed of trust interest in the real property time
4 share interval described in Exhibit "B" attached hereto and that TAHOE VILLAGE
5 CONDOMINIUM TIME SHARE OWNERS ASSOCIATION, the above-named Plaintiff, has title
6 thereto free and clear of any claim, right or deed of trust interest of JESSE E. TAYLOR, JR.,
7 THE CHARLES COMPANY, a Nevada corporation, BLANCHE JARRETT and JONI A.
8 JARRETT, MILDRED WEINHEIMER and LARRY J. MORGAN.

10 3. All fees and costs incurred in the above-entitled action shall be borne by the
11 Plaintiff.

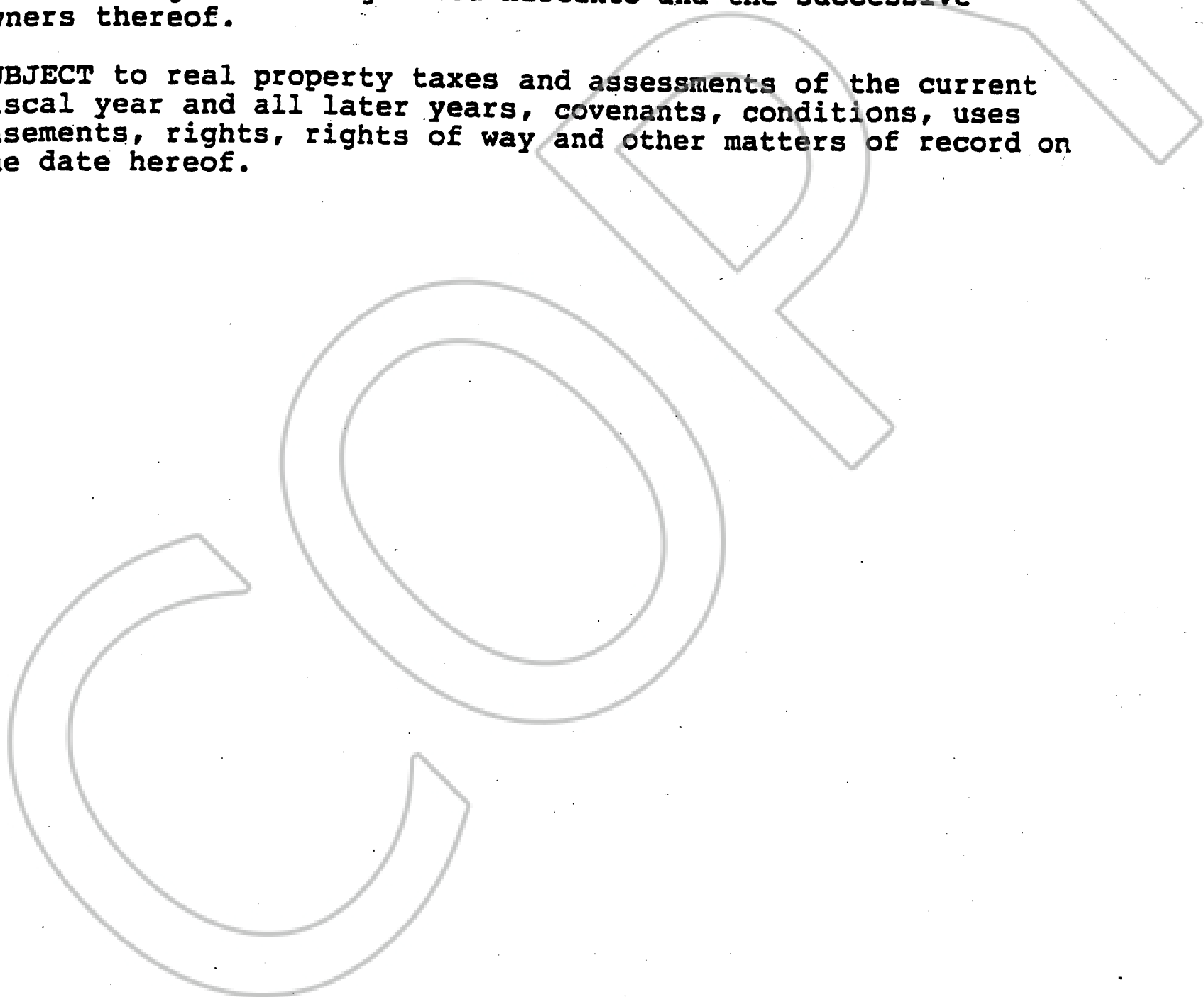
