

SUBSTITUTION OF TRUSTEE

WHEREAS, on May 15, 1993, James V. Callahan, D. 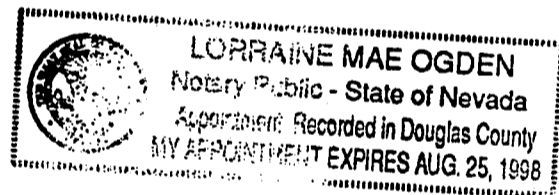
