STIPULATION OF JUDGMENT

15 Pursuant to Sections 17.090 through 17.110 of the Nevada  
16 Revised Statutes, Frank Cavataio ("Defendant") does hereby agree,  
17 stipulate, confess, and authorize, without notice or hearing, the  
18 entry of judgment against Defendant and in favor of Jimmy Roy  
19 Pelton and Suzanne Pelton ("Plaintiffs") in the amount of Forty-  
20 Three Thousand Dollars (\$43,000.00) (the "Judgment"), to be  
21 satisfied as follows:

22 (a) Plaintiff may not execute on the Judgment until the  
23 first day of the twenty-fifth calendar month after the execution  
24 of this Stipulation of Judgment;

25 (b) Defendant may not discharge the Judgment by bankruptcy  
26 any earlier than the first day of the twenty-fifth calendar month  
27 after the execution of this Stipulation of Judgment;

1 (c) On the first day of the twenty-fifth calendar month  
2 after the execution of this Stipulation of Judgment, Defendant  
3 shall make an initial payment of Fifteen Thousand Dollars  
4 (\$15,000.00) (the "Initial Payment") to Plaintiffs;

5 (d) Following the Initial Payment, Defendant shall make  
6 monthly payments to Plaintiffs, commencing on the first day of  
7 the first calendar month following the payment of the Initial  
8 Payment, in an amount mutually agreed to by both parties, until  
9 the Judgment is fully satisfied; and

10 (e) In the event of any noncompliance with the terms of  
11 this Stipulation of Judgment by Defendant, Plaintiffs may  
12 immediately execute on the Judgment to satisfy the still owing  
13 Judgment.

14 Defendant expressly agrees that upon the filing of this  
15 Stipulation of Judgment in the above court, judgment may be  
16 entered against Defendant by the clerk of this court as outlined  
17 above.

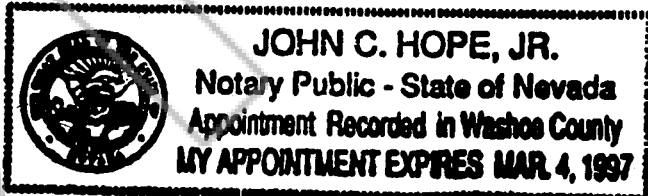
