

SUBSTITUTION OF TRUSTEE

WHEREAS, on May 14, 1990, Joseph M. 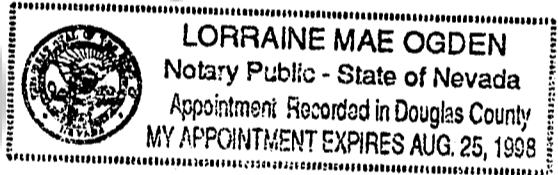
