

SUBSTITUTION OF TRUSTEE

WHEREAS, on August 15, 1991, Charles E. Whipple and Lynn E. 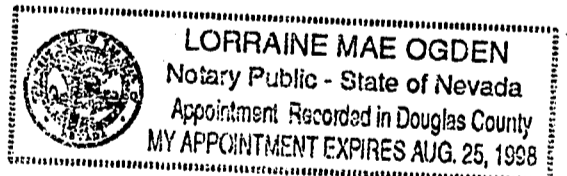
