**INTERLOCAL CONTRACT**

This Interlocal Contract is entered into between the Carson Water Subconservancy District, a political subdivision of the State of Nevada, by and through its duly constituted Board of Directors (hereinafter "CWSD"), and Douglas County, a political subdivision of the State of Nevada, by and through its duly constituted Board of County Commissioners (hereinafter "Douglas County").

The objective of this Interlocal Contract is to reimburse Douglas County for the \$30,000.00 it spent in matching funds on a study commissioned with the U.S. Geological Survey and published in 1994, to consider the potential for artificial recharge in Carson Valley. This study has regional significance in that it identifies several sites that may be used for conjunctive management of groundwater and surface water sources. Because of the status of the Douglas County Master Plan, further development of regional water resource studies is premature at this time. Douglas County plans to undertake the development of regional water resource studies once its Master Plan is adopted.

CWSD agrees to reimburse Douglas County with a payment of \$30,000.00.

Douglas County agrees to use the \$30,000.00 to pursue the development of regional water resource studies which may include conjunctive management of groundwater and surface water identified in the USGS artificial recharge study.

Douglas County further agrees to timely supply to CWSD at least two (2) complete copies of all reports and/or data generated by such future water resource studies which are funded, all or in part, by the \$30,000.00 reimbursement from CWSD. CWSD shall be entitled to further distribute any such reports or data to the other counties comprising CWSD.

Neither CWSD, nor Douglas County shall have any obligations or responsibilities except as described above.

In order for this Contract to become effective, each contracting entity must pass a resolution approving this Contract and authorizing an appropriate official to execute this Contract on its behalf. This Contract shall be void if the contracting entities have not passed such resolutions and signed this Contract by April 30, 1996.
