## WITNESSETH:

Grantors, for and in consideration of the grant of a reciprocal right-of-way, received by Grantors, do hereby grant to Grantee and its assigns an exclusive easement for and title to the existing roads over and across the following described lands in the County of Douglas, State of Nevada.

The acquiring agency is the Forest Service, Department of Agriculture.

The Grantors reserve to themselves and their successors in interest the right to use the existing roads or any segment thereof, subject only to compliance with traffic-control regulations and rules as provided in 36 CFR 261.12 and subject to the bearing of road maintenance costs only, proportionate to use as provided in 36 CFR 212.7(d).

If the Regional Forester determines that the roads, or any segments thereof, are no longer necessary, the easement traversed thereby shall terminate. Evidence for such termination shall be a statement in recordable form furnished by the appropriate Regional Forester to the Grantors or their successors or assigns in interest.

The Grantors hereby covenant that they, their heirs, executors, administrators, and assigns, shall warrant and forever defend unto the Grantee, its successors and assigns, the quiet and peaceable use and enjoyment of the herein granted easement against the lawful claims and demands of all persons whomsoever. This grant shall be binding upon the Grantors, their heirs, administrators, executors, and assigns, and shall run with and constitute a servitude upon the above described land.
