- 1. That I am competent to testify and have standing capacity to act as to the lawful matters herein; and further,
- 2. That I have personal, executive and documented knowledge of my status/state and the facts and evidence stated herein attached for my course of action; and further,
- 3. That all the facts and evidence stated herein are not heresay but true and correct, and admissable as evidence, if not rebutted and proved inaccurate; and further,

- 10. Thomas Michael Hillman and Elmira Elizabeth Coffe were one, joined in the state of holy wedlock at the time Thomas E. Hillman was natural born to them; and,
- 11. Thomas M. Hillman, Thomas E. Hillman's father, was sired by Francis Jerome Hillman, a Free, White male born on August 11, 1912, in the County of Los Angeles, in the State of California, a State of the Union States of America; and,
- 12. Thomas M. Hillman, Thomas E. Hillman's father, was given birth by, Alberta Olson, a Free, White female born on January 11, 1913, in the State of Missouri, a State of the Union States of America; and,
- 13. Francis Jerome Hillman and Alberta Olson were one, joined in the state of Holy wedlock at the time Thomas M. Hillman was natural born to them; and,
- 14. Elmira Elizabeth Coffe, Thomas E. Hillman's mother, was sired by Jess Earl Coffe, a Free, White male Ohio State Citizen, born on or about September 12, 1915, in the county of Summit, in the State of Ohio, a State of the Union States of America; and,
- 15. Elmira Elizabeth Coffe, Thomas E. Hillman's mother, was given birth by Elizabeth Miller, a Free, White female, born on or about February 20, 1917, in the county of Summit in the State of Ohio, a State of the Union States of America; and,
- 16. Jesse Earl Coffe and Elizabeth Miller, were one, joined in the state of Holy wedlock at the time Elizabeth Coffe was natural born to them; and
- 17. I affirm that I, Thomas Edward Hillman, am of the adamic race, as a white Christian male and that I do not nor would I ever voluntarily give up my inalienable (which means cannot be taken away) God given constitutionally secured Citizen rights and responsibilities. "The words 'people of the United States' and 'citizens' are synonymous terms, and mean the same thing. They both describe the political body who, according to our republican institutions, form the sovereignty, and who hold the power and conduct Government through their representatives. They are what we familiarly call the 'sovereign people'";

19. I affirm that I, Thomas Edward Hillman, being a direct descendant of the sovereign people, am fully vested with all Constitutionally mandated protection's to my life, liberty and property, for I am not an artificial person created by the 1935 Social Security Act, nor, the U.S. Constitution's 14th Amendment of 1868, for and because Nevada Constitution. Sec. 22 Preamble, Sec. 23 Constitution adopted, Sec. 24 Ordinance, and I remain under:

Preamble.

Whereas, The Act of Congress Approved March Twenty First A. D. Eighteen Hundred and Sixty Four "To enable the People of the Territory of Nevada to form a Constitution and State Government and for the admission of such State into the Union on an equal footing with the Original States," requires that the Members of the Covention for framing said Constitution shall, after Organization, on behalf of the people of said Territory, adopt the Constitution of the United States. Therefore be it Resolved,

United States Constitution Adopted

That the Members of this Convention elected by the Authority of the aforesaid enabling Act of Congress, Assembled in Carson City, the Capital of said Territory of Nevada, and immediately subsequent to its Organization, do adopt, on behalf of the people of said Territory the Constitution of the United States.

Ordinance

In obedience to the requirements of an Act of the Congress of the United States, approved March twenty-first, A.D. eighteen hundred and sixty-four, to enable the people of Nevada to form a constitution and state government, this convention, elected and convened in obedience to said enabling Act, do ordain as follows--and this ordinance shall be irrevocable, without the consent of the United States and the people of the State of Nevada:

I am not under the provisions of U.S. Const. Article IV, sec. 3, clause 3:

"The Congress shall have power to dispose of and make all needful rules and regulations respecting the territory or other **property** belonging to the United States and nothing in this Constitution shall be so construed as to prejudice any claims of the United States or of any particular state."

nor am I a person as described or defined in Title 26 U.S.C. Sec. 1 et seq., or Title 29 U.S.C. 49 et seq.,

Title 42 U.S.C. Sec. 301 through 1101(a)(3) nor in Nevada Statutes of law as further explained and defined in the Supreme Court case of Hale v. Henkel, 201 U.S. 43:

"... the individual may stand upon his constitutional rights as a Citizen. He is entitled to carry on his private business in his own way. His power to contract is unlimited. He owes no duty to the state or to his neighbors to divulge his business, or to open his doors to an investigation, so far as it may tend to incriminate him. He owes no duty to the state, since he receives nothing therefrom, beyond the protection of his life, liberty, and property. His rights are such as existed by the law of the land long antecedent to the organization of the State, and can only be taken from him by due process of law, and in accordance with the Constitution. Among his rights are a refusal to incriminate himself, and the immunity of himself and his property from arrest or seizure except under (a judicial power warrant) a warrant of the law. He owes nothing to the public so long as he does not trespass upon their rights."

And also, I am a judicial Power Citizen, as found in Paul v. Virginia, 8 Wallace 168, 177:

"The answer which readily occurs to the objection founded upon the first clause consists in the fact that corporations are not citizens within its meaning. The term citizens as then used applies only to natural persons, members of the body politic, owing allegiance to the State, not to artificial persons created by the legislature, and possessing only the attributes which the legislature has prescribed."

Wettengel v. Zimmerman, 249 Wis. 237, 24 N.W. 2d. 504, 506 (1946): "there are two classes of citizens in America" and also explained and defined by Justice O'Neal in State v. Simmon, 2 Spears 761, 767 (1884) and Justice Bronson in Taylor v. Porter, 4 Hill 140, 146 (1843):

"Preamble Citizens are not juristic persons nor State enfranchised persons under the 14th Amendment; neither are Natural Persons as De Jure Citizens subject to Legislative Dictum enforced by Legislative Tribunals/Courts proceeding in equity to deprive/usurp Common Law Rights. Law of the Land means the Common Law."

LAW ON STATE CITIZENSHIP STATUS AS OPPOSED TO THE 14TH AMENDMENT

The rights of Citizens of the States, as such, are **not** under consideration in the fourteenth amendment. They stand as they did before the adoption of the fourteenth amendment, and are fully guaranteed by other provisions.



Showers and thun-Barberton, Ohio, and a niece dershowers occurred near a frontal system if from the horthern Appalachians into the middle Mississippi valley this morning. There was also rain over western Texas and from the central Rockies into the west central plains. Rain and snow fell over the northern Rockies. Most of the precipitation was light.

Isolated severe weather occurred during Thursday afternoon and evening in the central and southern plains and parts of the Atlantic coast and Great Lakes. Five tornadoes were reported — two in Michigan, two in Texas and one in Colorado.

Weather elsewhere around the nation was rather quiet. Mostly clear skies prevailed through the upper Mississippi valley, the southern portions of the Rockies and plateau and in the southeast quarter of the nation. There were partly cloudy or cloudy conditions in other areas.


