That when defendant's minor child(ren) emancipate(s), defendant shall continue to pay \$200.00 per month toward satisfaction of then existing child support arrears in accordance with NRS 125B.100.

That defendant's ordered monthly payment on child support arrearages does not preclude other methods of collection for child support arrears.

This support order shall be reviewed every three years in accordance with NRS 125B.145.
