12 DEFAULT ORDER AND JUDGMENT

13 This matter was heard on May 3, 1996, before Jeffry
14 Millward, Child Support Hearing Master, with the following
persons present:

15 Petitioner not present and represented by the Douglas
16 County District Attorney's Office

17 Respondent was duly served but failed to appear by
himself or through counsel and did not request a continuance.

18 The Child Support Hearing Master has reviewed all
19 pleadings and papers on file herein, and makes this order by way
of default.

20 **AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:**

21 That the Court has jurisdiction of the parties and
22 subject matter of this case.

23 That the defendant was personally served with the
24 Notice of Intent to Enforce and/or modify an Order and Notice
of Hearing on March 22, 1996.

25 That on February 29, 1996, the Defendant requested a
26 continuance and was personally served on February 29, 1996, with
a Notice of Hearing setting this case for hearing on May 3, 1996.

27 That in a Judgment of Dissolution filed November 21,
28 1984, Defendant was ordered to pay the sum of \$150.00 per month
as ongoing support of his minor child, born July 24, 1982;

1 That the Defendant owes child support arrearages in
2 the amount of \$9,375.00 through May, 1996.

3 **THEREFORE, IT IS HEREBY ORDERED THAT:**

4 That the defendant is the parent of, and owes a duty
5 of support to, his minor child NATALIE S. CAPPS Born: 07/24/82

6 Judgment is entered in favor of plaintiff and against
7 defendant in the amount of \$9,375.00 for the period January
8 1992 through and including May 1996.

9 Defendant shall pay \$200.00 per month, by wage
10 withholding, to be paid as follows:

12 The defendant shall notify the Douglas County District
13 Attorney's Office of any change in home address, mailing address,
14 telephone number, employment, or medical insurance availability
15 within ten days of any change.

16 **IT IS FURTHER ORDERED THAT:**

17 Defendant's first monthly child support
18 obligation shall be due on the first day of June,
19 1996, and shall continue due on the first day of
20 each and every month thereafter until further order
21 of this court.

22 That when defendant's minor child(ren)
23 emancipate(s), defendant shall continue to pay
24 \$200.00 per month toward satisfaction of then
25 existing child support arrears in accordance with
26 NRS 125B.100.

27 That defendant's ordered monthly payment on
28 child support arrearages does not preclude other
methods of collection for child support arrears.

This support order shall be reviewed every
three years in accordance with NRS 125B.145.

That defendant's monthly child support
payments shall be in the form of a cashier's
check, certified check, or money order, or in
cash. If the payment is in the form of cash, it
must be delivered to the Douglas County Clerk at
her office in Minden, Nevada. If the payment is in
the form of a cashier's check, certified check, or
money order, it must be made payable to the
DOUGLAS COUNTY CLERK, must contain the notation
Case No. 950330 (CAPPS), and be either mailed to
the Douglas County Clerk at Post Office Box

1 1240, Minden, Nevada 89423, or delivered to
2 said County Clerk at her office the Minden Inn,
1594 Esmeralda Avenue, Suite 105, Minden, Nevada.

3 OBJECTIONS TO THIS ORDER MAY BE FILED WITH THE
4 DISTRICT COURT AND SERVED UPON THE OTHER PARTY WITHIN TEN (10)
5 DAYS OF RECEIPT OF THE CHILD SUPPORT HEARING MASTER'S
6 RECOMMENDATIONS.

7 IT IS SO RECOMMENDED THIS 3 day of May, 1996.
