

SUBSTITUTION OF TRUSTEE

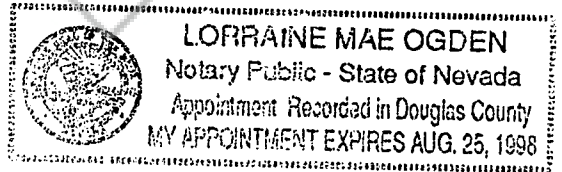

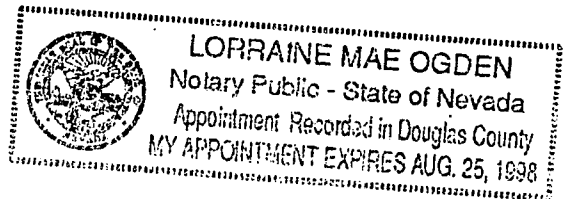
