

SUBSTITUTION OF TRUSTEE

WHEREAS, on April 1, 1993, Roger H. 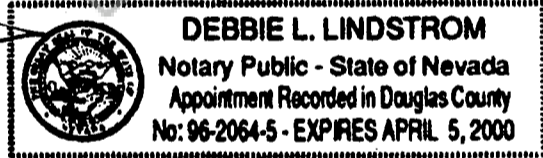
