

SUBSTITUTION OF TRUSTEE

WHEREAS, on May 30, 1992, Robert J. 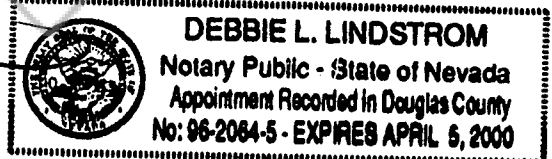

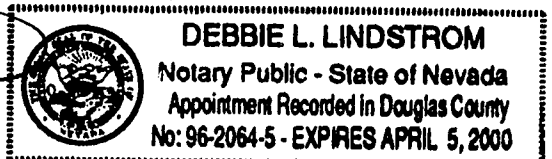
