6. Whereas at this time I do not understand the process and am thoroughly confused to the process that the Court is operating under.
7. Wherefore, I am requesting from Michael L. Ramsey, Butte County District Attorney, Brent Redelsperger, Deputy District Attorney, and Candice J. Grubbs, Butte County Clerk. to produce to me on a written affidavit sworn to under oath and substantiated beyond a reasonable doubt all allegations against me.
8. Whereas I hereby recind all my previous signed documents which Michael L. Ramsey or Brent Redelsperger have because they are products of duress or coercion.
