

**THE RIDGE TAHOE
GRANT, BARGAIN, SALE DEED**

THIS INDENTURE, made this 22nd day of June, 1996
between HARICH TAHOE DEVELOPMENTS, a Nevada general partnership, Grantor, and
RICHARD MACHADO and BEVERLY A. MACHADO, husband and wife as joint tenants as to
an undivided 1/2 interest and MICHAEL PARDOVICH and JUANITA D. PARDOVICH,
Grantee; husband and wife as joint tenants as to an undivided 1/2 interest
