## DEFAULT ORDER AND JUDGMENT

This Court has reviewed plaintiff's Application for Default and all pleadings and papers on file herein, and makes this order by way of default.

Petitioner is represented by the Douglas County District Attorney's Office.

Respondent was duly served but failed to file an answer and did not request a conference with the District Attorney's Office, Child Support Division.

AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

That the Court has jurisdiction of the parties and subject matter of this case.

That the defendant was personally served with the Notice of Finding of Financial Responsibility on June 10, 1996.

That the defendant is the parent of, and owes a duty of support to his minor children: SIERRA CHERIE LASKOWSKI Born: 11/11/95; and JORDAN LASKOWSKI Born: 12/07/91.

That based upon notice given to Defendant in the Finding of Financial Responsibility which was served upon Defendant by personal service on June 10, 1996, Defendant owes child support arrearages to the State of Nevada in the amount of \$15,214.00.

That based upon information received from the State of Nevada, Plaintiff MONICA J. LASKOWSKI, is no longer receiving

public assistance from the State of Nevada, and has not requested enforcement of ongoing child support.

## THEREFORE, IT IS HEREBY ORDERED THAT:

That the defendant is the parent of the following Born: 12/07/91; and SIERRA CHERIE children: JORDAN LASKOWSKI Born: 11/11/95 LASKOWSKI

Judgment is entered in favor of Nevada State Welfare and against defendant in the amount of \$15,214.00 for the period December 1991 through and including May 30, 1996.

Defendant shall pay \$200.00 per month, by wage withholding, to be paid as follows:

\$250.00 REIMBURSEMENT SPOUSAL SUPPORT

\$250.00 TOTAL:

Defendant and Plaintiff shall share joint legal custody of the minor child with primary physical custody with MONICA J. LASKOWSKI. This provision is made under authority of NRS 126.161 (5), and is made for the protection of the minor child. The parties' have been advised that this Court does not have jurisdiction over custody and visitation. The parties have further been advised to contact a private attorney to establish a visitation schedule.

The child's birth certificate shall be changed and an amended birth certificate issued indicating that DARRYL J. LASKOWSKI is the father of SIERRA CHERIE LASKOWSKI, born November 11, 1995.

The defendant shall notify the Douglas County District Attorney's Office of any change in home address, mailing address, telephone number, employment, or medical insurance availability within ten days of any change.

## IT IS FURTHER ORDERED THAT:

Defendant's monthly child first arrearage payment shall be due on the first day of August, 1996, and shall continue due on the first day of each and every month thereafter until further order of this court.

defendant's minor children That. when emancipate, defendant shall continue to pay \$250.00 per month toward satisfaction of then existing child support arrears in accordance with NRS 125B.100.

That defendant's ordered monthly payment support arrearages does not preclude other methods of collection for child support arrears.

This support order shall be reviewed every three years in accordance with NRS 125B.145.

That defendant's monthly child support payments shall be in the form of a cashier's

check, certified or money order, cash. ; If the payment is in the form of cash, must be delivered to the Douglas County her office in Minden, Nevada. If the pay If the payment is in the form of a cashier's check, certified check, or money it must be made order, payable DOUGLAS COUNTY CLERK, must contain the notation 960119 (LASKOWSKI), and be either mailed Case No. the Douglas County Clerk at Post Office 1240, Minden, 89423, or delivered Nevada said County Clerk office in the Minden at her 1594 Esmeralda Avenue, Suite 105, The Nevada. Douglas County Clerk transmit said payments to: the State of Nevada.
