13 DEFAULT ORDER AND JUDGMENT

14 This Court has reviewed plaintiff's Application for
15 Default and all pleadings and papers on file herein, and makes
16 this order by way of default.

17 Petitioner is represented by the Douglas County
18 District Attorney's Office.

19 Respondent was duly served but failed to file an
20 answer and did not request a conference with the District
21 Attorney's Office, Child Support Division.

22 **AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:**

23 That the Court has jurisdiction of the parties and
24 subject matter of this case.

25 That the defendant was personally served with the
26 Notice of Finding of Financial Responsibility on June 10, 1996.

27 That the defendant is the parent of, and owes a duty
28 of support to his minor children: SIERRA CHERIE LASKOWSKI
Born: 11/11/95; and JORDAN LASKOWSKI Born: 12/07/91.

That based upon notice given to Defendant in the
Finding of Financial Responsibility which was served upon
Defendant by personal service on June 10, 1996, Defendant owes
child support arrearages to the State of Nevada in the amount of
\$15,214.00.

That based upon information received from the State of
Nevada, Plaintiff MONICA J. LASKOWSKI, is no longer receiving

1 public assistance from the State of Nevada, and has not
2 requested enforcement of ongoing child support.

3 **THEREFORE, IT IS HEREBY ORDERED THAT:**

4 That the defendant is the parent of the following
5 children: JORDAN LASKOWSKI Born: 12/07/91; and SIERRA CHERIE
6 LASKOWSKI Born: 11/11/95

7 Judgment is entered in favor of Nevada State Welfare
8 and against defendant in the amount of \$15,214.00 for the
9 period December 1991 through and including May 30, 1996.

10 Defendant shall pay \$200.00 per month, by wage
11 withholding, to be paid as follows:

17 Defendant and Plaintiff shall share joint legal
18 custody of the minor child with primary physical custody with
19 MONICA J. LASKOWSKI. This provision is made under authority of
20 NRS 126.161 (5), and is made for the protection of the minor
21 child. The parties' have been advised that this Court does not
22 have jurisdiction over custody and visitation. The parties have
23 further been advised to contact a private attorney to establish
24 a visitation schedule.

25 The child's birth certificate shall be changed and an
26 amended birth certificate issued indicating that DARRYL J.
27 LASKOWSKI is the father of SIERRA CHERIE LASKOWSKI, born
28 November 11, 1995.

The defendant shall notify the Douglas County District
Attorney's Office of any change in home address, mailing address,
telephone number, employment, or medical insurance availability
within ten days of any change.

IT IS FURTHER ORDERED THAT:

Defendant's first monthly child support
arrearage payment shall be due on the first day of
August, 1996, and shall continue due on the first
day of each and every month thereafter until further
order of this court.

That when defendant's minor children
emancipate, defendant shall continue to pay \$250.00
per month toward satisfaction of then existing child
support arrears in accordance with NRS 125B.100.

That defendant's ordered monthly payment on
child support arrearages does not preclude other
methods of collection for child support arrears.

1 This support order shall be reviewed every
2 three years in accordance with NRS 125B.145.

3 That defendant's monthly child support
4 payments shall be in the form of a cashier's
5 check, certified check, or money order, or in
6 cash. If the payment is in the form of cash, it
7 must be delivered to the Douglas County Clerk at
8 her office in Minden, Nevada. If the payment is in
9 the form of a cashier's check, certified check, or
10 money order, it must be made payable to the
11 DOUGLAS COUNTY CLERK, must contain the notation
12 Case No. 960119 (LASKOWSKI), and be either mailed
13 to the Douglas County Clerk at Post Office Box
14 1240, Minden, Nevada 89423, or delivered to
15 said County Clerk at her office in the Minden
16 Inn, 1594 Esmeralda Avenue, Suite 105, Minden,
17 Nevada. The Douglas County Clerk shall
18 transmit said payments to: the State of Nevada.
