

SUBSTITUTION OF TRUSTEE

WHEREAS, on December 29, 1990, Miryam E. 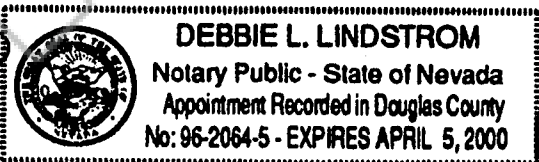

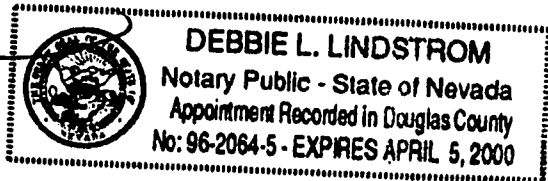
