

SUBSTITUTION OF TRUSTEE

WHEREAS, on February 15, 1992, Julian R. 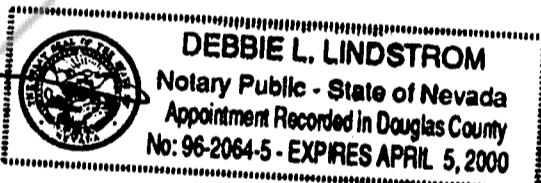

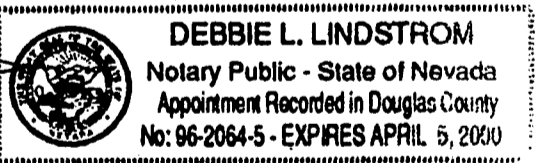
