

SUBSTITUTION OF TRUSTEE

WHEREAS, on March 24, 1990, Mark A. 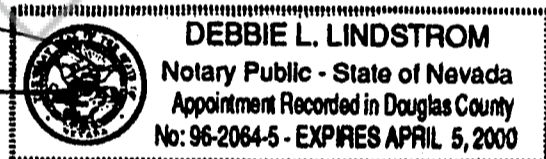

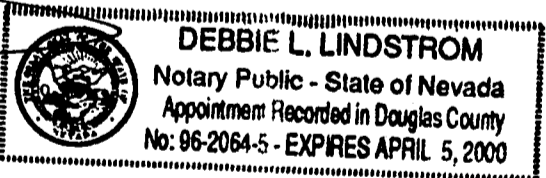
