- 2. That the use for which the property is sought to be condemned is authorized by law and is a public use and the taking in condemnation by Plaintiff is necessary for that public use.
- 3. That Defendant, FREDERIC APCAR, shall have final judgment against Plaintiff, DOUGLAS COUNTY, for the following:
- (a) The sum of \$200,000.00, plus interest from October 13, 1995, through March 8, 1996, at the statutory rate of 5.47% in the amount of \$4,615.78, with credit for sums of \$202,965.91 and \$3,000.00, previously paid, leaving a credit of \$1,350.13 against sums due Defendant as hereinafter set forth;
- (b) The sum of \$7,680.00 for mitigation fees paid to the Tahoe Regional Planning Agency;
 - (c) Attorney's fees in the amount of \$2,500.00;
- (d) Costs from October 1, 1995, through July 31, 1996 of \$188.92.
- 4. That Findings of Fact and Conclusions of Law and Notice of Entry of Judgment may be and the same are hereby waived.
