1 IT IS HEREBY ORDERED, ADJUDGED and DECREED as follows:

2 1. Defendants, REM SYSTEMS, INC., PHOENIX HEALTH
3 SYSTEMS, INC., PHOENIX HEALTH SYSTEMS, VICTOR N. KING, CARLA KING,
4 and DONALD L. WILLIS, and each of them be, and they hereby are,
5 permanently enjoined from taking any action in connection with
6 transferring or assigning interests, or infringing upon the
7 copyrights held by COMPREHENSIVE in the personal property
8 previously foreclosed upon by COMPREHENSIVE, described generally
9 as follows:

10 a. The computer software programs REMEDY, Hospice
11 M.I.S., REM VOYAGER, REM HOST I & HOST II, and REMCOM;

12 b. The foregoing shall include both the object
13 codes and source codes for each of the programs.

14 2. Judgment is hereby entered against REM SYSTEMS,
15 INC., PHOENIX HEALTH SYSTEMS, INC., and PHOENIX HEALTH SYSTEMS and
16 in favor of Plaintiff, COMPREHENSIVE, as follows:

17 a. In the amount of \$187,731.14, representing the
18 total principal amount of the loans set forth in the Second
19 Amended Verified Complaint filed herein;

20 b. Attorneys fees in the amount of \$12,626.⁰⁰,
21 and costs in the amount of \$1306.73;

22 c. Interest at the legal rate to commence
23 accruing on the date of entry of this Judgment, until said
24 Judgment is paid in full.
