

SUBSTITUTION OF TRUSTEE

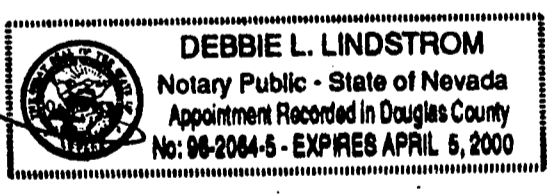
