

SUBSTITUTION OF TRUSTEE

WHEREAS, on October 10, 1993, Herbert N. Jones and Parris R. 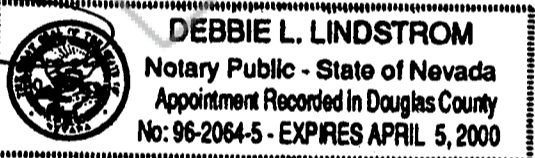

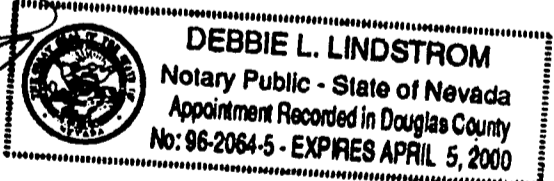
