STIPULATION

ALAN WAYNE WRIGHT,

COMES NOW, Plaintiff DENISE MARIE DIEDERICH, by and through her attorney GARY L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and Defendant, ALAN WAYNE WRIGHT, who hereby agree and stipulate as follows:

1. That in a Decree of Divorce filed May 25, 1995, in the Ninth Judicial District Court of the State of Nevada, In and for Douglas County, Defendant was ordered to pay the sum of \$225.00 per month as ongoing child support of his minor child, CHELSI CAITLYN WRIGHT Born: 08/10/93.

2. That in a subsequent Order and Judgment After Hearing filed June 13, 1996, in the Ninth Judicial District Court of the State of Nevada, In and For Douglas County, Defendant was again ordered to pay \$225.00 per month as ongoing

1 child support together with \$50.00 per month toward satisfaction
2 of child support arrearages in the amount of \$1,665.00.
3

4 3. That Defendant owes child support arrearages in
5 the amount of \$1,840.00 through and including July 31, 1996.
6 That Defendant is currently unemployed, and an additional
7 \$225.00 will be added to Defendant's arrearages representing the
8 month of August, 1996, for a total child support arrearage of
9 \$2,065.00 through and including August 1, 1996.

10 4. That the Defendant shall pay \$225.00 per month as
11 ongoing support, plus \$50.00 per month toward satisfaction of
12 child support arrears for a total of \$275.00 per month. That
13 Defendant's first \$275.00 monthly payment shall be due on
14 September 1, 1996, and continue due on the first day of each
15 and every month thereafter until further order of this court.

16 5. That Defendant's child support payments shall be
17 made by wage withholding.

18 6. Defendant understands that, in the event he
19 becomes unemployed or underemployed, all child support payments
20 to be made by him to Plaintiff must be in the form of a
21 cashier's check, certified check, or money order, or in cash.
22 The Defendant further understands that if the payment is in the
23 form of cash it must be delivered to the Douglas County Clerk at
24 her office in Minden, Nevada. If the payment is in the form of
25 a cashier's check, certified check, or money order, Defendant
26 understands that it must be made payable to the DOUGLAS COUNTY
27 CLERK, with the notation Case No. 960141 (ALAN WAYNE WRIGHT),
28 and be either mailed to the Douglas County Clerk at Post Office

1 Box 218, Minden, Nevada 89423, or delivered to said County Clerk
2 at her office in Minden, Nevada.

3 7. That the Plaintiff has not requested enforcement
4 of health insurance.


5 8. Defendant agrees that he shall notify the Douglas
6 County District Attorney's Office in writing within 10 days of
7 any change in Defendant's mailing address, home address, or
8 employment.


9 9. Defendant understands that this support order may
10 be reviewed every three years at the request of either party in
11 accordance with NRS 125B.145.

12 10. Defendant understands that failure to pay his
13 support as required by the order entered in accordance with this
14 stipulation will subject him to possible contempt of court with
15 a penalty of 25 days in jail.

16 11. That except as modified herein the terms and
17 conditions of the orders entered May 25, 1995 and June 13,
18 1996, shall remain in full force and effect.
