

SUBSTITUTION OF TRUSTEE

WHEREAS, on September 7, 1992, Loren D. Price and Ethel E. 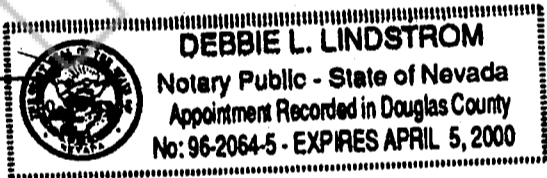

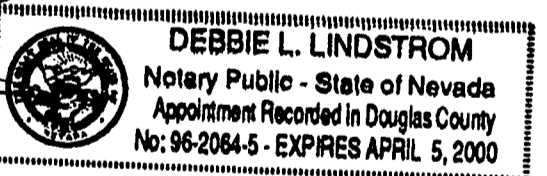
