10 insurance coverage for the child(ren) when available through  
11 Respondent/Obligor's employer or other group policy; and  
12 Respondent/Obligor shall provide all reasonable and necessary  
13 assistance to enable the Petitioner/Obligee to obtain the  
14 medical benefits offered by the policy of insurance.

15 6. (✓) Pursuant to NRS 125B.080.7, expenses for health  
16 care which are not reimbursed through insurance, including  
17 expenses for medical, surgical, dental, orthodontic and optical  
18 expenses, must be borne equally by both parents in the absence  
19 of extraordinary circumstances.

20 7. (✓) The Respondent/Obligor shall notify the Douglas  
21 County District Attorney's Office, Child Support Division, at  
22 782-9881, of any change of address, employment or change in the  
23 availability of health insurance coverage within ten (10) days  
24 of such change.

25 8. (✓) **THIS IS AN INCOME WITHHOLDING ORDER.** A mandatory  
26 wage withholding shall be initiated against the  
27 Respondent/Obligor's wages or commissions. This does not  
28 preclude the use of other means to collect any arrears or  
enforce this order, including garnishment, liens, attachments,

1 execution on real or personal property or interception of  
2 Federal Income tax refunds.

3 9. ( ) GOOD CAUSE BEING FOUND BY THE COURT: \_\_\_\_\_

5 said wage withholding shall be postponed until such time as the  
6 Respondent/Obligor becomes (30) days delinquent in payment. NO

15 District Court, all enforcement procedures, including but not  
16 limited to wage withholding, garnishments, liens and the  
17 interception of Federal Income tax refunds, will be undertaken  
18 upon entry of this Order.

19 12. (✓) Interest upon the amount of the judgment for  
20 arrears shall accrue at the rate set by NRS 99.040.

21 13. ( ) Prejudgment interest is awarded from \_\_\_\_\_

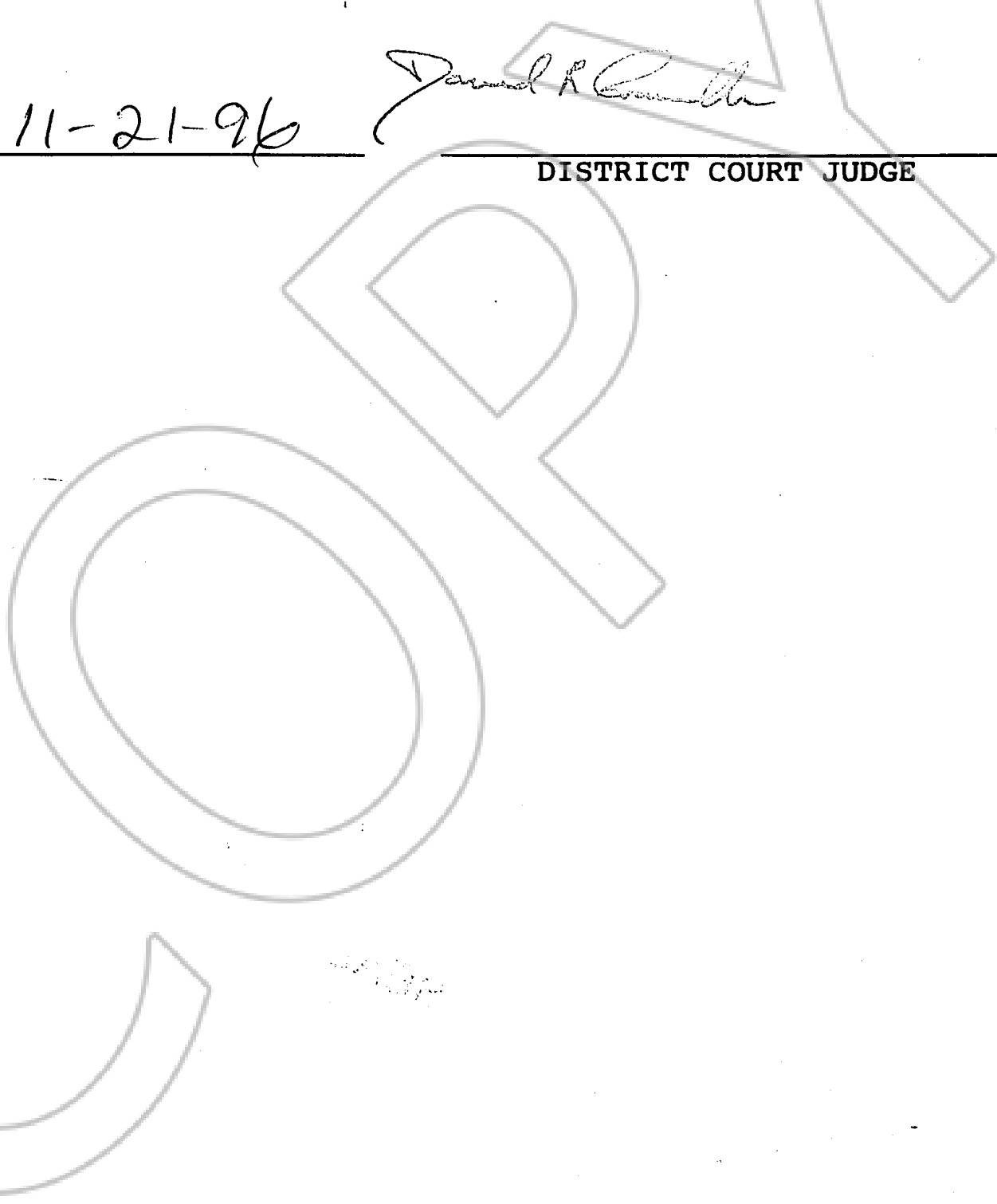
