for payment of the indebtedness secured by said Deed of Trust.



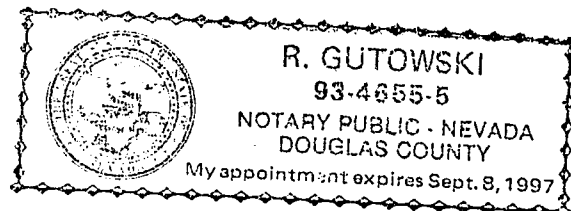
