COMES NOW, Plaintiff PAMELA KAY CONDRON, by and through her attorney GARY L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and Defendant, JEFFERY LLOYD POLLOCK, who hereby agree and stipulate as follows:

1. That in a Decree of Divorce filed November 4, 1994, in the Ninth Judicial District Court of the State of Nevada, In and For the County of Douglas, Defendant was ordered to pay 18% of his gross monthly income as ongoing support of his minor child, JORDAN KAY POLLOCK Born: 12/16/89.

2. That Defendant currently earns \$2,080.00 per month, working as a concrete operation manager. That based upon Defendant's monthly income and applying the formulas set forth in NRS 125B.070, to wit: 18%, Defendant's monthly child support obligation is \$374.40.

2 3. That Defendant owes \$748.80 in child support  
3 arrearages for the months of September and October 1996.

4 4. That the Defendant shall pay \$374.00 per month as  
5 ongoing support, plus \$37.00 per month toward satisfaction of  
6 child support arrears for a total of \$411.00 per month. That  
7 Defendant's first \$411.00 monthly payment shall be due on  
8 November 1, 1996, and continue due on the first day of each  
9 and every month thereafter until further order of this court.

10 5. Defendant and Plaintiff hereby waive the immediate  
11 wage withholding requirement. Defendant understands that a wage  
12 withholding will be initiated by the District Attorney's Office  
13 without further notice if Defendant becomes 30 days delinquent  
14 in his child support obligation.

15 6. Defendant understands that all child support  
16 payments to be made by him to Plaintiff must be in the form of a  
17 cashier's check, certified check, or money order, or in cash.  
18 The Defendant further understands that if the payment is in the  
19 form of cash it must be delivered to the Douglas County Clerk at  
20 her office in Minden, Nevada. If the payment is in the form of  
21 a cashier's check, certified check, or money order, Defendant  
22 understands that it must be made payable to the DOUGLAS COUNTY  
23 CLERK, with the notation Case No. 960266 (JEFFERY LLOYD  
24 POLLOCK), and be either mailed to the Douglas County Clerk at  
25 Post Office Box 218, Minden, Nevada 89423, or delivered to said  
26 County Clerk at her office in Minden, Nevada.

27 7. That the Plaintiff has not requested medical  
28 enforcement services.

2 8. Defendant agrees that he shall notify the Douglas  
3 County District Attorney's Office in writing within 10 days of  
4 any change in Defendant's mailing address, home address, or  
5 employment.

6 9. Defendant understands that this support order may  
7 be reviewed every three years at the request of either party in  
8 accordance with NRS 125B.145.

9 10. Defendant understands that failure to pay his  
10 support as required by the order entered in accordance with this  
11 stipulation will subject him to possible contempt of court with  
12 a penalty of 25 days in jail.
