LOAN MODIFICATION AGREEMENT (Providing for Fixed Interest Rate)

This modification is being rerecorded to correct the P & I amount and the maturity date.

In consideration of the mutual promises and agreements exchanged, the parties hereto agree as follows (notwithstanding anything to the contrary contained in the Note or Security Instrument):

- As of December 2, 1996 the amount payable under the Note and the Security Instrument (the "Unpaid Principal Balance") is U.S. \$290,500.00, consisting of the amount(s) loaned to the Borrower by the Lender and any interest capitalized to date.

If the Lender exercises this option, the Lender shall give the Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is delivered or mailed within which the Borrower must pay all sums secured by the Security Instrument.
