Should she be unable or unwilling to so 14 act, then MERCY BELICARIO BROPHY, born March 31, 1974, shall Should she be unable or 15 become the "successor trustee". 16 unwilling to so act, then FRANIS BELICARIO BROPHY, born October 17 20, 1975, shall become the "successor trustee". Should she be 18 unable or unwilling to so act, then KATIE EUGENIA GARCIA, born 1980, shall become the "successor trustee". 20 "Successor Trustee" shall have no bond required of him or her and 21 agrees not to request any compensation in regards to any duties.

Upon the death of either of us, the survivor, as "surviving 23 trustee", shall be entitled to continue using any and all of the 24 "trust assets" as before, until the survivor's death. Upon the 25 death of the survivor the "successor trustee" shall take charge 26||of the Trust, with all powers and control, and disburse the assets as follows, after liquidation:
