15 COMES NOW, Plaintiff ALANA R. DELIMA, by and through
16 GARY L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and Defendant, JAMES
17 HERBERT DELIMA JR, who hereby agree and stipulate as follows:

18 1. That Defendant is the father of DELIAH DIANE
19 DELIMA Born: 01/12/91; ARIEL ROXANE DELIMA Born: 06/17/92; and
20 JAMES HERBERT DELIMA III Born: 03/24/94.

21 2. That Defendant owes \$7,425.00 in child support
22 arrearages for the period from January, 1995, through and
23 including March, 1997.

24 3. That Defendant currently earns \$953.00 per month,
25 working for Superior Lube. That based upon Defendant's monthly
26 income and applying the formulas set forth in NRS 125B.070, to
27 with: 29%, Defendant's monthly child support obligation is
28 \$275.00.

1 4. That the Defendant shall pay \$275.00 per month as
2 ongoing support, plus \$25.00 per month toward satisfaction of
3 child support arrears for a total of \$300.00 per month. That
4 Defendant's first \$300.00 monthly payment shall be due on
5 April 1, 1997, and continue due on the 1st day of each and
6 every month thereafter until further order of this court.

7 5. That Defendant's child support payments shall be
8 made by wage withholding.

9 6. Defendant understands that, in the event he
10 becomes unemployed or underemployed, all child support payments
11 to be made by him to Plaintiff must be in the form of a
12 cashier's check, certified check, or money order, or in cash.
13 The Defendant further understands that if the payment is in the
14 form of cash it must be delivered to the Douglas County Clerk at
15 her office in Minden, Nevada. If the payment is in the form of
16 a cashier's check, certified check, or money order, Defendant
17 understands that it must be made payable to the DOUGLAS COUNTY
18 CLERK, with the notation Case No. 960336 (JAMES HERBERT DELIMA
19 JR), and be either mailed to the Douglas County Clerk at Post
20 Office Box 218, Minden, Nevada 89423, or delivered to said
21 County Clerk at her office in Minden, Nevada.

22 7. That the Defendant shall provide medical insurance
23 coverage for his minor children if available through employment
24 or other group policy.

25 8. Defendant agrees that he shall notify the Douglas
26 County District Attorney's Office in writing within 10 days of

1 any change in Defendant's mailing address, home address, or
2 employment.

3 9. Defendant understands that this support order may
4 be reviewed every three years at the request of either party in
5 accordance with NRS 125B.145.

6 10. Defendant understands that failure to pay his
7 support as required by the order entered in accordance with this
8 stipulation will subject him to possible contempt of court with
9 a penalty of 25 days in jail.
