13 DEFAULT ORDER AND JUDGMENT

14 This Court has reviewed plaintiff's Application for
15 Default and all pleadings and papers on file herein, and makes
16 this order by way of default.

17 Petitioner is represented by the Douglas County
18 District Attorney's Office.

19 Respondent was duly served but failed to file an
20 answer and did not request a conference with the District
21 Attorney's Office, Child Support Division.

22 AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

23 That the Court has jurisdiction of the parties and
24 subject matter of this case.

25 That the defendant was personally served with the
26 Notice of Finding of Financial Responsibility on August 29,
27 1996.

28 That the defendant is the parent of, and owes a duty
of support to, the following
child: DANICA WELTON Born: 10/03/95

That based upon employment verifications, Defendant
currently earns \$2,600.00 per month, working as an
electrician. That based upon Defendant's monthly income and
applying the formulas set forth in NRS 125B.070, to wit: 18%,
Defendant's monthly child support obligation is \$468.00.

1 That the defendant owes child support arrears in the
2 amount of \$8,156.00 for the period October 1995, through and
including May 1997.

4 **THEREFORE, IT IS HEREBY ORDERED THAT:**

5 That the defendant is the parent of the following
6 child: DANICA WELTON Born: 10/03/95

7 Judgment is entered in favor of plaintiff and against
8 defendant in the amount of \$8,156.00 for the period October
1995 through and including May 1997.

9 Defendant shall pay \$515.00 per month, by wage
withholding, to be paid as follows:

12 The defendant will secure and maintain medical health
13 insurance on the above named child when available through
14 employment or other group policy. The Defendant is ordered to
15 continue, upon the request of the Douglas County District
Attorney's Office, to provide it with information regarding the
availability of health insurance.

16 Custody of the minor child shall remain with the
17 mother, PAMELA GRAY. This provision is made under authority of
18 NRS 126.161 (5), and is made for the protection of the minor
19 child. The parties' understand that the Douglas County District
Attorney's Office does not have authority to litigate matters
regarding custody and visitation.

20 The child's birth certificate shall be changed and an
21 amended birth certificate issued indicating that DAVID R. WELTON
is the father of DANICA WELTON.

22 The defendant shall notify the Douglas County District
23 Attorney's Office of any change in home address, mailing address,
24 telephone number, employment, or medical insurance availability
within ten days of any change.

24 **IT IS FURTHER ORDERED THAT:**

25 Defendant's first monthly child support
26 obligation shall be due on the 1st day of June,
1997, and shall continue due on the first day of
27 each and every month thereafter until further order
of this court.

28 That when defendant's minor child emancipates,
defendant shall continue to pay \$515.00 per month

1 toward satisfaction of then existing child support
2 arrears in accordance with NRS 125B.100.

3 That defendant's ordered monthly payment on
4 child support arrearages does not preclude other
5 methods of collection for child support arrears.

6 This support order shall be reviewed every
7 three years in accordance with NRS 125B.145.

8 That defendant's monthly child support
9 payments shall be in the form of a cashier's
10 check, certified check, or money order, or in
11 cash. If the payment is in the form of cash, it
12 must be delivered to the Douglas County Clerk at
13 her office in Minden, Nevada. If the payment is in
14 the form of a cashier's check, certified check, or
15 money order, it must be made payable to the
16 DOUGLAS COUNTY CLERK, must contain the notation
17 Case No. 960174 (WELTON), and be either mailed
18 to the Douglas County Clerk at Post Office Box
19 1240, Minden, Nevada 89423, or delivered to
20 said County Clerk at her office in the Minden
21 Inn, 1594 Esmeralda Avenue, Suite 105, Minden,
22 Nevada.
